- 2 We confirm that, as at 31 March 2021:
  - a. i) the Minimum Value of the Charged Properties is £265,471,569; and  
i) the Charged Cash is 0,  
(the sum of which being the **Aggregate Asset Value**); and
  - b. the aggregate principal amount of the Bonds outstanding (excluding, for this purpose, any Retained Bonds held by or on behalf of the issuer) is £250,000,000therefore, the Aggregate Asset Value is not less than the aggregate principal amount of the Bonds outstanding (excluding, for this purpose, any Retained Bonds held by or on behalf of the Issuer). Accordingly the Issuer is in compliance with the Asset Cover Test.
